REVISED Monitoring Guideline for COVID-19 situation in Enterprises under the purview of the Board of Investment of Sri Lanka

Considering the current COVID-19 outbreak situation in the country, the Ministry of Health has taken a policy decision to monitor all the workers in export oriented manufacturing industries under the purview of the Board of Investment of Sri Lanka in order to ensure safety of workforce as well as citizens of Sri Lanka.

Therefore, please confirm that PCR testing is done in minimum of 1% daily of the workforce in consultation with the area Medical Officer of Health (MOH) in all Enterprises under the purview of the Board of Investment of Sri Lanka on daily basis. PCR testing to be done preferably in an accredited private sector laboratory to ease off the current burden to the government sector laboratories. Please find below the list of accredited private laboratories with PCR testing facilities.

1. Nawaloka Hospital Laboratories
2. Durdens Hospital Laboratories
3. Asiri Laboratories
4. Lanka Hospitals Laboratories

Further, as already been advised, please ensure that COVID-19 prevention health guidelines are strictly adhered to in all work settings. Each factory should have an identified focal point for this purpose. The name and contact details of the focal points of all factories should be informed to the Environmental and Occupational Health Unit of the Ministry of Health and the area Medical Officer of Health.
