1. The Chairman, Standing High Level Procurement Committee on behalf of the Board of Investment of Sri Lanka (BOISL) now invites sealed bids from eligible and qualified bidders for Construction of Internal Wastewater Collection Network & Pumping System for the Textile Manufacturing Zone (ETMZ) at Punnaikudha, Eravurpattu, Batticaloa.
2. The estimated cost of this work is Rs. 750 million approximately (including SSCL) plus VAT.
3. The Contract period is 21 months (Construction, Testing Commissioning period is 18 months and trial Operation & Maintenance period is 03 months).
4. Bidding will be conducted through National Competitive Bidding Procedure.
5. To be eligible for Contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements at the time of submission of Bid.

Required CIDA Registration

Specialty: Water Supply & Sewerage

Grade: C3 and above

6. Qualification requirements to qualify for contract award include:
Experience as a contractor for successfully completed at least one project of construction of 1000cum/day (minimum) capacity sewerage or water intake pump house including mechanical & electrical installations and 0.5 km long 250 mm nominal diameter gravity sewer pipe laying work for wastewater collection system over the period of last 10 years.

9. Bids must be delivered with a duplicate to reach the Chairman, Standing High Level Procurement Committee, C/o Actg. Executive Director (Technical Services), Board of Investment of Sri Lanka, Technical Services Department, Level 5, World Trade Centre-West Tower, Echelon Square, Colombo 01 at or before 1400hrs on 06.02.2026. Late Bids shall be rejected. Bids will be opened soon after closing time and in the presence of the bidders' representatives who choose to attend.
10. Bids shall be valid up to 03.07.2026.
11. All Bids must be accompanied by a bid security of Rs. 10,000,000.00 comply with the format annexed. Bid security shall be valid up to 31.07.2026
