The Chairman, Department Procurement Committee (DPC) on behalf of the Board of Investment of Sri Lanka (BOI) invites sealed proposals from the reputed Insurance companies who are registered with the Insurance Regulatory Commission of Sri Lanka (IRCSL) and operating in Sri Lanka for the provision of Health Insurance Cover for Hospitalization (In-Patient) and Routine Medical Expenses (Out-Patient) for the employees and their dependents of the Board of Investment of Sri Lanka for a period of one (01) year commencing from **15 March 2026**.
2. Only the Head Office of the relevant insurance company is entitled to obtain the RFP Document and submit proposals. In any case, submitting the proposals through branch/es of the same company shall not be considered for the evaluation.
3. Insurance brokers are not entitled to obtain the RFP Document and submit proposals.
4. The intended service period is one year (extendable if required by the BOI).
5. Bidding will be conducted through National Competitive Bidding Procedure.
6. Eligible Bidders shall have previous experience in similar assignments worth Rs.100Mn or above or catered to client organizations of 500 employees or more at least in one organization during the last five (05) years.
