

Investment Incentives

Enhanced Capital Allowance (ECA)

Applicable to new projects and expansions by existing BOI projects.

Depreciable Assets:

Class 1: computers and data handling equipment together with peripheral devices.

Class 2: buses and minibuses, goods vehicles, construction and earthmoving equipment, heavy general purpose or specialised trucks, trailers and trailer-mounted containers, plant and machinery used in manufacturing.

Class 3: railroad cars, locomotives, and equipment, vessels, barges, tugs, and similar water transportation equipment, aircraft, specialised public utility plant, equipment, and machinery, office furniture, fixtures and equipment, any depreciable asset not included in another class.

Class 4: buildings, structures and similar works of a permanent nature.

Class 5: intangible assets, excluding goodwill.

Exemption from all taxes and levies

(Customs duty, PAL, CESS and VAT)

- Importation of construction related items during project implementation period
- Importation of Capital items (plant, machinery, equipment)
- Importation of raw materials and production/process-related consumables for both production for export including deemed exports and import substitution via sales to the local market)

Income Tax on Employment

- Up to ten (10) expatriate employees of the enterprise shall be exempt from income tax arising from gains and profits from employment in the enterprise in the zone for a period of five (05) years.

Note: The supply of construction materials, Capital goods, Raw materials, or Production/process-related consumables from any registered person who is registered with the VAT administration system (E.g. SVAT) administrated by the commissioner-general to the enterprise will also be exempted from payment or charge of VAT. Importation includes purchases from bonded areas of Customs and BOI.


