INVITATION FOR BIDS (IFB)

- 1 The Chairman, Board of Investment of Sri Lanka on behalf of Chairman, Standing High Level Procurement Committee (SHLPC) now invites sealed bids from eligible and qualified bidders for Construction of 2,000m³/day capacity Water Treatment Plant of Horana Export Processing Zone (HEPZ) Water Supply Scheme.
- 2 Bidding will be conducted through National Competitive Bidding Procedure.
- 3 Alternative bids shall not be accepted.
- 4 To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have Registration with CIDA in the field of Water Supply & Sewerage in Grade C3 and above at the time of submission of the bid and work as a main contractor for completion of minimum 500m³/per day capacity water or wastewater treatment plant including Mechanical and Electrical works with minimum value of Rs.300 Mn during last 10 years.
- 5 The estimated cost for this Bid is Rs 583.30 Million (Including SSCL) without VAT and the contract period is 24 months (construction period 18 calendar months + trial operational period 06 calendar months).

Executive Director (Technical Service), Technical Service Department, Board of Investment of Sri Lanka from 19/05/2026 until 15/06/2026 from 09:00 hours to 15:00 hours on normal working days upon payment of a non-refundable document fee of Rs.100,000/= (including Taxes) in cash.
- 8 Bids shall be delivered in duplicate to the Chairman, Standing High Level Procurement Committee C/o Actg. Executive Director (Technical Service), Technical Service Department, Board of Investment of Sri Lanka, Level-5, West Tower, World Trade Centre, Echelon Square, Colombo 01, Sri Lanka on or before 14:00 hours on 16/06/2026. Late Bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
- 9 All Bids shall be accompanied by a bid security of Rupees 10 million and valid up to 23/12/2026
